The purpose of this notice is to inform you about how Wizz Air processes your personal data and what you can do and what rights you have as a data subject when using site for the “Lifetime memories with Wizz” promotion.

### 1. INFORMATION RELATIVE TO DATA CONTROLLER(S)

### 4. INFORMATION ABOUT THE DATA BEING PROCESSED FOR SPECIFIC PURPOSES

In connection with “Lifetime memories with Wizz” promotion we will use your personal data for the purposes listed below and we process your data on the following legal basis.

To process your personal data, Wizz Air will rely on the legal bases below:

Your consent provided to us under Article 6 (1) a) EU Regulation 679/2016 ("GDPR") (“**Consent**”).

Wizz Air may process your data outlined in point 4. for the following purposes and activities with the following legal bases:

## 5. HOW LONG DO WE KEEP YOUR PERSONAL DATA?

Wizz Air stores your personal data only as long as necessary for the performance of Wizz Air's obligations and strictly for the time necessary to achieve the purposes for which the information was obtained. The personal data will be removed from Wizz Air's records or properly anonymized when it is no longer needed. If Wizz Air process your personal data based on your consent, Wizz Air will process and store your personal data until your consent is withdrawn.

For the purpose indicated under point 3., Wizz Air will keep your data for the following retention periods:

<b>GOVERNMENT AUTHORITIES AND ENFORCEMENT BODIES</b>	<i>Wizz Air may share your personal data with government authorities or enforcement bodies such as regulatory authorities, upon their request and only as required by the applicable law or to protect our rights or the safety of our customers, staff and assets.</i>		

## 7. AUTOMATED DECISION-MAKING

We inform you that the processing activities we pursue do not involve automated decision making, including profiling based on automated processes.

## 8. INFORMATION RELATIVE TO YOUR RIGHTS

<b>YOUR RIGHTS</b>	<i>For the purpose outlined in point 3., you are entitled to exercise your data protection rights.</i>
<b>RIGHT TO ACCESS</b>	You have a right to ask whether or not Wizz Air have personal data about you and, if that is the case, request information on what personal data Wizz Air have.  Wizz Air may request additional information from you for identification or for further copies requested by you, Wizz Air may charge a reasonable fee based on administrative costs.
<b>RIGHT TO RECTIFICATION</b>	Wizz Air is required to rectify inaccurate personal data, or to complete personal data that is incomplete, on request.
<b>RIGHT TO ERASURE (RIGHT TO BE FORGOTTEN)</b>	Wizz Air is in some circumstances required to erase personal data on request by the data subject.
<b>RIGHT TO RESTRICTION OF PROCESSING</b>	Wizz Air is in some circumstances required to restrict our use of personal data on request by the person concerned. In such cases, Wizz Air may only use the data for certain limited purposes set out by the law.
<b>RIGHT TO DATA PORTABILITY</b>	You may have the right to receive your personal data to which Wizz Air have access, in a structured, commonly used and machine-readable format and such persons may then have a right to transmit those data to another entity without hindrance from us.

### WITHDRAW OF CONSENT

**You have the right to withdraw your consent freely, at any time. The withdrawal of your consent does not affect the lawfulness of the prior data processing.**

### RIGHT TO OBJECT

**You have the right to object to the processing of your personal data for any reason relating to your situation, and in this case, Wizz Air may not be able to process your personal information. If you have the right to object and the exercise of this right is justified, your personal data in concern will not be further processed for the purposes of the objection. The exercise of this right does not entail any costs.**
