

## Privacy Notice for Scavenger Hunt (Austria) participants

(Last updated: 4 September 2024)

The purpose of this Privacy Notice ("Privacy Notice") is to provide you detailed information about how we process your data in connection with your participation in the **Scavenger Hunt (Austria) contest**, hereinafter referred to as **Campaign**. The Privacy Notice helps you to better understand how we use your personal data and explains how we collect it, what we use it for and with whom it is shared. <b>JOINT DATA CONTROLLERS</b>	<p><b>WIZZ Air Hungary Ltd.</b> (seat: Lecher Ödön fasor 6., H-1095, Budapest, Hungary; "<b>Wizz Air</b>") and <b>Unique Public Relations GmbH</b> (seat: Schönbrunnerstraße 297-307, Stiege 1, 3rd Floor, 1120 Vienna, Austria); Wizz Air and Unique Public Relations GmbH hereinafter jointly referred to as '<b>Controllers</b>', '<b>we</b>' or '<b>us</b>') operate as joint data controllers when processing your personal data in connection with your participation in the Campaign.</p> <p>Wizz Air is the main point of contact and responsible for taking care of your privacy related requests, queries or complaints. Irrespective of the terms of the arrangement, you may exercise your rights in respect of and against each of the joint data controllers, Wizz Air is also responsible for providing you with information in relation to this processing (as set out in this Privacy Notice) and notifying the relevant supervisory authority in the event of a data breach.</p>									
<b>WHAT IS THE PURPOSE OF PROCESSING THE DATA?</b>	<p>We will use your data for the purposes below:</p> <ol style="list-style-type: none"> <li>1) <b>Wizz Air Account Management:</b> in order to be able to participate in the Campaign, you will have to have a registered Wizz Account.</li> <li>2) <b>Contacting winners:</b> in order to contact and notify winners, we process the given contact data/Wizz Account data.</li> <li>3) <b>Marketing communications:</b> in order to promote the Campaign, we are using the pictures of winners and the Instagram handles of participants.</li> </ol> <p>If we wish to use your personal data for a new purpose, not covered by this Privacy Notice, we will provide you with a new notice explaining all conditions relating to the new processing prior to the new processing takes place. If required, we will seek your consent before commencing the new data processing activity.</p>									
<b>WHAT PERSONAL DATA WE PROCESS ABOUT YOU?</b>	<p>For the purposes outlined above we process the data categories indicated below:</p> <ol style="list-style-type: none"> <li>A. <b>Wizz Air Account:</b> including passenger birth date, passenger gender, passenger name, passenger nationality, passenger resident country, passenger travel document expiry, passenger travel document id, passenger travel document issuing country, passenger travel document type, customer name, customer nationality, customer phone.</li> <li>B. <b>Contact data:</b> name, phone number, email address.</li> <li>C. <b>Marketing communications:</b> photographs, Instagram handles.</li> </ol> <p>Please be aware that if we need to perform a contract between you and us or provide you with our services or personalized offers, we will need your personal data. If you do not provide us with the requested personal data, we will not be able to provide you with all or parts of the services you have requested from us.</p>

	<b>Wizz Air Account Management</b>	<p>To create and maintain your Wizz Account, to identify you as a user and give you access to the services and features we offer to our registered users, and to manage your Wizz Credits. The processing of your data is necessary for the fulfilment and execution of the <a href="#">Wizz Account Terms and Conditions</a>.</p>	
	<b>Contacting winners</b>	<p>Contacting winners is necessary to fulfil the contest's obligations, such as awarding prizes and confirming winner identities. This processing is directly related to the contest's operation and cannot be achieved without using personal data.</p>	
	<b>Photo-taking</b>	<p>We have assessed the processing of personal data for photographing and interviewing winners. The processing of photographs and interviews is intended to promote the event and highlight winners' voucher usage. This is based on the winners' consent, as per Article 6(1)(a) of the GDPR. The processing is necessary and proportionate for event promotion and involves minimal privacy intrusion, using only relevant photographs and statements. <b>By participating, winners consent to this data use and have been informed of their rights.</b></p>	
	<b>Using Instagram handles</b>	<p>We have assessed the processing of personal data concerning the use of participants' Instagram handles for promotional purposes. The use of Instagram handles is intended for promotional activities related to the Campaign. This is based on the winners' consent, as per Article 6(1)(a) of the GDPR. The use of Instagram handles is necessary and proportionate for promoting the Campaign, involving minimal impact on participants' privacy. Instagram handles will be used solely for the intended promotional purposes and will not be shared with third parties without additional consent. <b>By entering the Campaign, participants consent to the use of their Instagram handles as described and have been informed of their rights.</b></p>	
<b>HOW LONG DO WE KEEP YOUR PERSONAL DATA?</b>	<p>We process your personal data for the time required consistent with the purposes set out in this Privacy Notice or for the period of limitation prescribed in the relevant laws.</p>		
	<b>Purpose of data processing</b>	<b>Retention Time</b>	
	<b>Wizz Air Account Management</b>	<p>We keep your personal data for a period of 6 years from the fulfilment of the contract concluded with us in order to comply with applicable data retention laws.</p> <p>We need to keep your personal data relative to your flights (PNR) for 5 years, which data we pseudonymize after 6 months from your flight with us.</p>	
	<b>Contacting winners</b>  <b>Marketing communications (including photo-taking and handling Instagram handles)</b>	<p>The Controllers erase all personal data collected during the Campaign, including but not limited to participants' full names, phone numbers, Wizz Air account numbers, email addresses, photographs and Instagram handles, upon the conclusion of the Campaign and after all prizes have been successfully awarded. This erasure will occur within a reasonable timeframe following the end of the Campaign, not exceeding 30 days, unless retention is required by law or for legitimate business purposes directly related to the Campaign.</p>	
<b>WHO MAY HAVE ACCESS TO YOUR DATA?</b>	<p>WIZZ Air Hungary Ltd. (seat: Lecher Ödön fasor 6., H-1095, Budapest, Hungary) and Unique Public Relations GmbH (seat: Schönbrunnerstraße 297-307, Stiege 1, 3rd Floor, 1120 Vienna, Austria) operate as joint data controllers when processing your personal data in connection with your participation in the Campaign.</p>		
<b>YOUR RIGHTS</b>	<p>You are entitled to exercise your rights indicated below:</p> <p>(i) <u>Right of access</u>: You have a right to ask whether we process personal data about you and, if that is the case, request information on what personal data we have. We will also have to respond to</p>		

	<p>questions about inter alia why we are using your personal data, details about what data we have and to whom we have provided access to the data. Please note that this is not an absolute right and the interests of other individuals may restrict your access rights.</p> <p>We may request additional information from you for identification or for further copies requested by you, we may charge a reasonable fee based on administrative costs.</p> <p>(ii) <b>Right to rectification:</b> We are required to rectify inaccurate personal data, or to complete personal data that is incomplete, on your request.</p> <p>For more information in relation to Wizz Air's rules of name change correction, please click <a href="#">here</a>.</p> <p>(iii) <b>Right to erasure (right to be forgotten):</b> We are in some circumstances required to erase your personal data on your request.</p> <p>(iv) <b>Right to restriction of processing:</b> We are in some circumstances required to restrict our use of personal data on your request. In such cases, we may only use the data for certain limited purposes set out by the law.</p> <p>(v) <b>Right to data portability:</b> You may have the right to receive your personal data to which we have access, in a structured, commonly used and machine-readable format and you may then have a right to transmit those data to another entity without hindrance from us.</p> <p>(vi) <b>Right to object:</b></p> <div data-bbox="416 674 1385 808" style="border: 1px solid black; background-color: #e91e63; color: white; padding: 5px;"> <p><b>You have the right to object to the processing of your personal data for any reason relating to your situation, and in this case, we may not be able to process your personal information. If you have the right to object and the exercise of this right is justified, your personal data in concern will not be further processed for the purposes of the objection.
