

WIZZ DISCOUNT CLUB TERMS AND CONDITIONS

1. INTERPRETATION

1.1. Terms and expressions defined in the General Conditions of Carriage of Wizz Air shall have the same meaning when used in this Terms and Conditions unless set out below or unless the context otherwise requires.

1.2. Definitions

“General Conditions of Carriage” means the general conditions of carriage of Wizz Air as published on the Website and amended by Wizz Air from time to time.

“Member” or “You” the person named as the member of the Wizz Discount Club during the application for the Club membership.

“Wizz Discount Club” or “Club” means Our special offer which entitles Members to certain benefits as specified herein.

“Wizz Account Number” means the 10-digit identification number created by the reservation system upon completion of myWizz registration.

2. ELIGIBILITY AND REGISTRATION

2.1. You can join the Wizz Discount Club (i) online via the booking flow by completing the application form and by paying the annual Club membership fee; or (ii) via Our Call Centre when you are making a booking and apply for the membership via the Call Centre and by paying the annual Club membership fee.

2.2. Membership fee will be advised to You at the time of application.

2.3. We reserve the right to refuse membership to any person and – in case of breach of these Terms and Conditions by the Member - terminate membership at any time.

2.4. Membership is conditioned to subscription to Wizz Air’s special offers. When you join the Club you will automatically subscribe for Wizz Air’s special offers with the e-mail address you provided when you created your Wizz Account.

2.5. You may unsubscribe from the special offers at any time.

3. PAYMENT OF THE MEMBERSHIP FEE

3.1. When You apply for the Club Membership You shall pay the annual membership fee. Payment of the annual fee cannot be made with bank transfer.

3.2. A Members will not be entitled to any refund of any membership fees upon cancellation of membership in the Club.

4. BENEFITS OF THE MEMBERSHIP

4.1. Wizz Discount Club membership entitles members to special Club fares, which are not available to non-members, and other benefits as advised to You at the time of application for membership and may be updated during the membership.

4.2. Membership in the Club does not guarantee availability of special Club fares on all routes and at all times. Special Club fares are particularly not available on domestic routes and on special flights scheduled for sport events.

4.3. Benefits can change with prior notice to You.

4.4. We reserve the right to change, enhance or reduce benefits at any time. We may also impose requirements or restrictions on the use of benefits. Current information is set out on [WIZZ Discount Club](#) .If You do not accept any amendments, You may terminate your membership by writing to Us.

4.5. Benefits are personal and apply only to You if you are named as a Passenger in a booking and to certain number of Passengers (as set out on [WIZZ Discount Club](#)), if they are in the same booking as You and the total number of passengers in the booking does not exceed the number of beneficiaries of the WIZZ Discount Club modality chosen, and such booking is made under Your Wizz Account Number.

4.6. Benefits are not available for Passenger(s) booked by You separately.

4.7. Benefits will not be refunded to Members for reservations booked prior to the commencement of the membership.

4.8. Club membership is non-transferable. You must promptly notify Us upon becoming aware of any unauthorized use of Your Club membership.

5. GENERAL PROVISIONS

5.1. All promotions, fares, and any other special offers provided by Wizz Air are subject to the terms and conditions specifically pertaining to that offer. Unless otherwise agreed by Us, the benefits of the Wizz Discount Club cannot be combined with other offers.

5.2. Tickets and/or services purchased by using the Club membership shall not be offered for commercial purposes by You or a third party, especially on internet auctions or other web-based platforms.

5.3. In case of change in the reservation You must ensure that You remain a Passenger in the booking at all time in order that other Passengers in the same booking could benefit from the Club fares. If You are removed from the booking, the regular fare will be applicable to all remaining Passengers and the fare difference shall be paid, otherwise We may cancel the reservation. Alternatively one of the other Passenger in the booking shall become a Member to keep Club benefits for the remaining Passengers in the booking.

5.4. You shall provide accurate and true personal information when applying for a Club membership and shall maintain that information when using any Club benefits. If you fail to comply with the above obligation, We reserve the right at Our sole discretion to terminate Your membership.

5.5. We reserve the right to unilaterally amend these Terms and Conditions at any time by publishing the amended Terms and Conditions of Use on the Website.

5.6. Unless specified otherwise herein, to bookings made or services purchased on Our Website by using the Club membership, the General Conditions of Carriage apply.

6. TERM AND TERMINATION

6.1. Club membership commences when We accept Your application and You pay the membership fee to Us.

6.2. The membership is valid for 12 (twelve) calendar months commencing on the day of the acceptance of Your application. You may extend Your Club membership within one month prior to the expiry date when you are making a booking by paying the Club membership fee. Membership fee will be advised to you upon extension. If You extend Your membership as specified above, the extended term will start on the day immediately subsequent to the expiry date. If Your membership expired, You may apply for a new Club membership at any time afterwards when you are making a booking.

6.3. You may cancel Your Club membership at any time by selecting the unsubscribe option on My Profile page.

6.4. Once membership is terminated, cancelled or expires, You will not be entitled to the Club benefits.

6.5. We may terminate Your membership at any time by written notice to You.

7. USE OF YOUR PERSONAL DATA

7.1. By registering for Club membership, You agree to Wizz Air processing Your data in accordance with the Privacy Policy.

8. GOVERNING LAW

8.1. These Terms and Conditions are subject to Hungarian law and the non-exclusive jurisdiction of Hungarian Courts.
