

Website terms and conditions

1. General, Interpretation

This website is owned and operated by Wizz Air Hungary Ltd. (registered seat is at 1103 Budapest, Kőér street 2/A, Building B., Floor II/V., Hungary; hereinafter referred to as “Wizz Air”).

For the purposes of these Terms and Conditions: references to “You” and “Your” refers to the persons accessing this website (including persons who access this site on the behalf of other persons) and “website” includes also the mobile website and the Wizz Air mobile application.

2. Use of the website

Your use of this website indicates Your agreement to be bound by and act in accordance with these Terms and Conditions in consideration of the access provided to the website as detailed below.

If You disagree to these Terms and Conditions, You are not permitted to, and agree not to use or access to this website.

3. Permitted use

The purpose of this website is solely to permit You to view the availability of Wizz Air goods and services and to make travel arrangements with Wizz Air (or third party providers), to purchase travel related services, manage Your bookings ,contact Wizz Air or to provide investors’ / financial information and for no other purpose.

You may only use this website in accordance with these Terms and Conditions and only for Your private, non-commercial purposes.

In particular, You are not permitted to:

- without Wizz Air’s prior written consent, use any automated system, algorithm or software to monitor, extract, search or copy any material or data (in whole or in part) from or through using this website (‘screen scraping’);
- make any fraudulent booking;
- use any software, routine or device or take any action to interfere or attempt to interfere in any way with the operation of this website or to create an unreasonably large load on this website, whether or not this was done intentionally;
- attempt to obtain or obtain unauthorised access to any of Wizz Air’s networks or accounts or to information about other users; or
- link to this website without Wizz Air’s prior written consent.

In case of breach of these Terms and Conditions by you, without prejudice to any of other rights of Wizz Air, Wizz Air may cancel Your bookings and purchases without notice; and/or deny or block Your access to this website; or set special conditions on Your access to or use of this website.

4. Proprietary rights

All information, data and materials on this website (including but not limited to any logos, the appearance, structure, color scheme and layout of this website, the software code and the underlying data and database) are subject to trade mark rights, copyright, database rights and/or other registered and unregistered intellectual property rights.

Where these Terms and Conditions are translated into languages other than Hungarian in the event of any conflict or inconsistency the Hungarian language Terms and Conditions shall prevail.

Wizz Air reserve the right to bring proceedings against any party which is in breach of these Terms and Conditions ("defaulting party") in the courts of the location of the breach, the courts of the country of the defaulting party's residence at Our sole discretion.

Wizz Air may also amend these Terms and Conditions at any time without prior notice, and such modification shall be effective immediately upon publishing the amended Terms and Conditions on the website which is deemed to be accepted by You if You continue to use the website.
