

WIZZ DISCOUNT CLUB TERMS AND CONDITIONS

1. INTERPRETATION

- 1.1. Terms and expressions defined in the General Conditions of Carriage of Wizz Air shall have the same meaning when used in this Terms and Conditions unless set out below or unless the context otherwise requires.
- 1.2. Definitions

General Conditions of Carriage means the general conditions of carriage of Wizz Air as published on the Website and amended by Wizz Air from time to time.

Member or **You** the person named as the member of the Wizz Discount Club during the application for the Club membership.

Wizz Discount Club or **Club** means Our special offer compilation, operated based on and according to the present Terms and Conditions, which entitles Members to certain benefits as specified herein.

Wizz Account Number means the 10-digit identification number created by the reservation system upon completion of the Wizz Air registration.

Wizz Air or **Us** means the Wizz Air entity (Wizz Air Hungary Ltd or Wizz Air UK Ltd or any other Wizz air entity) operating the flight with which You have purchased the WIZZ Discount Club membership and which issues the invoice for the WIZZ Discount Club purchase.

2. ELIGIBILITY AND REGISTRATION

- 2.1. You can join the Wizz Discount Club:
 - online via the booking flow by purchasing the Club membership and paying the annual membership fee when booking a flight;
 - via Our Call Centre when You are making a booking and purchase the membership via the Call Centre and pay the annual Club membership fee.
- 2.2. Membership fee will be advised to You at the time of purchase.
- 2.3. We reserve the right to refuse membership to any person and – in case of breach of these Terms and Conditions by the Member - terminate membership at any time.

3. PAYMENT OF THE MEMBERSHIP FEE

- 3.1. When You purchase the Club Membership You shall pay the annual membership fee. Payment of the annual fee can be made by bank card and/or WIZZ Credit.

4. BENEFITS OF THE MEMBERSHIP

- 4.1. Wizz Discount Club membership entitles Members to special Club fares, which are not available to non-members, and other benefits as advised to You at the time of purchase of the membership.
- 4.2. Membership in the Club does not guarantee availability of special Club fares on all routes and at all times (e.g.: domestic routes, flights operated for a special event, etc).
- 4.3. Benefits can be changed with prior notice to You.
- 4.4. We reserve the right to change, enhance or reduce benefits at any time. We may also impose requirements or restrictions on the use of benefits. Current information on the benefits is available on wizzair.com under WIZZ Services. If You do not accept any amendments, You may

terminate Your membership by writing to Us. In this case, Clause 6.5 of the present Terms and Conditions applies.

- 4.5. Benefits are valid for the WIZZ Discount Club member and other Passengers included in the same booking, given that the total number of Passengers in the booking does not exceed the number of beneficiaries of the WIZZ Discount Club membership type purchased.
- 4.6. Benefits are not available for Passenger(s) booked by You separately.
- 4.7. Benefits will not be refunded to Members for reservations booked prior to the purchase of the membership.
- 4.8. Club membership is non-transferable. You must promptly notify Us upon becoming aware of any unauthorized use of Your Club membership.
- 4.9. Regardless of which entity You have purchased the WIZZ Discount membership from, You are entitled to the benefits related to all flights of all Wizz Air entities according to the present Terms and Conditions.
- 4.10. Benefits are valid for only one booking per given flight in accordance with the WIZZ Discount Club membership type. On a specific flight only one booking can be made using the benefits of the WIZZ Discount Club membership. In case of non-compliance with the present Clause, Wizz Air reserves the right to cancel the reservations.

5. GENERAL PROVISIONS

- 5.1. All promotions, fares, and any other special offers provided by Wizz Air are subject to the terms and conditions specifically pertaining to that offer. Unless otherwise agreed by Us, the benefits of the Wizz Discount Club cannot be combined with other offers.
- 5.2. Tickets and/or services purchased by using the Club membership shall not be offered for commercial purposes by You or a third party, including but not limited to internet auctions or other web-based platforms.
- 5.3. In case of change in the reservation You must ensure that You remain a Passenger in the booking at all time in order that other Passengers in the same booking could benefit from the Club fares. If You are removed from the booking, the regular fare will be applicable to all remaining Passengers and the fare difference (the differences of the regular and WIZZ Discount Club ticket price and the regular and WIZZ Discount Club baggage fee) shall be paid, otherwise We may cancel the reservation.
- 5.4. You shall provide accurate and true personal data when purchasing the Club membership and shall maintain that data when using any Club benefits. If You fail to comply with the above obligation, We reserve the right at Our sole discretion to terminate Your membership.
- 5.5. We reserve the right to unilaterally amend these Terms and Conditions at any time by publishing the amended Terms and Conditions of Use on the Website.
- 5.6. Unless specified otherwise herein, to bookings made or services purchased on Our Website by using the Club membership, the General Conditions of Carriage of the flight operating Wizz Air entity apply.

6. TERM AND TERMINATION

- 6.1. Club membership commences when Your purchase the membership and You pay the membership fee to Us.
- 6.2. The membership is valid for 12 (twelve) calendar months commencing on the day of the purchase of Your membership.

- 6.3. Once membership is terminated, cancelled or expires, You will not be entitled to the Club benefits.
- 6.4. We may terminate Your membership at any time by written notice to You.
- 6.5. In case You decide to terminate Your membership, please note that the annual membership fee is not refundable, neither in total nor partially.

7. WIZZ DISCOUNT CLUB MEMBERSHIP FOR COBRANDED CREDIT CARD HOLDERS

- 7.1. Cobranded credit card holders are entitled for WIZZ Discount Club Standard membership without paying the membership fee.
- 7.2. The cobranded card related WIZZ Discount Club membership is valid for 12 months. The WIZZ Discount Club membership is activated once the credit card holder activates his WIZZ Account online.
- 7.3. The WIZZ Discount Club membership shall be automatically prolonged with an additional year as long as the credit card is active.
- 7.4. Those credit card holders who already have a valid WIZZ Discount Club membership, will be entitled to the Standard membership set forth in Clause 7.1, once the previous membership expired.
- 7.5. In case the credit card expires or the credit card agreement is terminated either by the bank or the credit card holder, Wizz Air reserves the right to terminate the WIZZ Discount Club membership.
- 7.6. For WIZZ Discount Club members who are credit card holders, all other provisions of the present Terms and Conditions are applicable in accordance with Clause 7.

8. USE OF YOUR PERSONAL DATA

- 8.1. By purchasing Club membership, You agree to Wizz Air processing Your personal data in accordance with the Privacy Notice.

9. GOVERNING LAW

- 9.1. These Terms and Conditions are subject to Hungarian law and the non-exclusive jurisdiction of Hungarian Courts.
